#### PRIVACY POLICY

This Privacy Policy describes Our policies and procedures on the collection, use, and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You. We use Your Personal data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy. ## Interpretation

#### **Definitions**

## Personal Data

You can implement a standard opt-out preference signal through any legitimate web browser. When our website recognizes a standard opt-out preference.

## Usage Data

Usage Data is collected automatically when using the Service.

## Use of Your Personal Data

The Company may use Personal Data for the following purposes:

This information is necessary for Serenite Insurance LLC to process claims in compliance with applicable law.

#### Retention of Your Personal Data

We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

## Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

## **Business Transactions**
